Treasurer Allen Talbert:

Approval of Minutes

Barb White inquired about the meeting minutes being distributed prior to the DDSC meeting. The response is they are on DDSC's website for people to review. Jay Innes recommended that an email be sent when the meeting minutes have been uploaded along with the link.

Old Business

 Jay Innes clarified that the draft Interpreter Bill is using "spoken English" which is not inclusive of Certified Deaf Interpreters (CDIs). He and the committee recommended using the current RID definition, passed at the last national meeting which is more inclusive.

New Business

 Joey DeLusant moved that we do not pursue the idea about inviting Dr. Wilson of WA to present about dementia. Instead, we will invite Beebe Hospital to discuss the topic of dementia at a future meeting. Nancy Childs seconded. Passed.

- Joey DeLusant moved to bring a deaf AARP rep, Peter Rozynski, to teach the sixhour Smart Driver course to us. John Padden seconded. Passed.
- Joey DeLusant moved to approve the \$17.99 annual fee for DDSC's domain website.
 Hazel Rinas seconded. Passed.
- Mike Childs moved to table the discussion on fundraising to next month's meeting with hopes that more people will be in attendance. Pee Wee DeGeorge seconded. Passed.
- Jay Innes moved that we formalize the committee (Gordon Bergan, Billy Bowman, Norma Buemi, Joey DeLusant, Mindy Failing, Jay Innes, Dennise Scott, Allen Talbert, and Barbara White) for the Interpreter Bill. Jerry Buyas seconded. Passed.
- Billy Bowman moved to remove the holiday dinner from our budget item. If the ladies lunch group needs to borrow funds, they can ask us. Jay Innes seconded. Passed.
- Allen Talbert moved that we formally approve Lisa Jacobs as secretary. This will be tabled until next month's meeting.

Discussion Items

- There was a brief discussion about the purpose and mission of DDSC. Allen Talbert mentioned that several people have stated that DDSC was becoming too "political"; for example, the interpreter bill should be the domain of DAD. We reviewed the By Laws and mission statement. It was suggested that DDSC alternate educational and recreational activities. We noted that we no longer can have drinks and refreshments prior to the meeting at the South Coastal Library in Bethany Beach which may have an impact on attendance. DDSC officers need to appoint someone to chair the social committee and to research other meeting location options for the purpose of providing drinks and refreshments.
